

## **SAFETY MANAGER - SOLAR FIELD**

This position is to assist our clients to minimize the risk of job-related accidents and ensure OSHA compliance. You will monitor operations to eliminate hazardous activities.

Safety coordinators should be well-versed in OSHA compliance. The work will be focused on prevention, so you need to be diligent and analytical. This position possesses a keen eye for detail and a sensitivity for potential dangers.

### **Requirements**

- Must have 5 years hands-on relevant work experience in a manufacturing/construction setting.
- Solar Field experience.
- Electrical background is preferred but not required
- Must possess at minimum, valid OSHA 500 certification. Must have current CPR and First Aid Certification.
- CHST, DEGREE in Safety is preferred.
- Bilingual is preferred but not required.
- In-depth knowledge of OSHA guidelines and practices Experience in daily reporting to management
- Experience in implementing OSHA training programs. Proficient in MS Office
- Excellent communication and advisory skills Must have a current, valid driver's license.
- Must be eligible to work in the United States

### **Responsibilities**

- Ensure workers and the general public are kept safe from harm
- Conduct field safety/audit inspections
- Suggest to workers proper safe work practices
- Identify and coordinate safety improvement plans to ensure the continuous improvement of
- safety in new and existing products, processes, and procedures
- Enforce OSHA policies (e.g., accident reporting process)
- Maintain and apply knowledge of current health and safety policies, regulations, and industrial
- processes
- Identify and correct potential hazards by inspecting facilities, machinery, and safety equipment
- Maintain all OSHA required programs, training, logs, records, and reports
- Partner with Client in accident investigation procedures

- Keep records of safety-related incidents and propose corrective actions
- Other duties may be assigned per project as required

### **Work Availability**

- Must maintain regular and acceptable attendance at such levels as is determined by management.
- Must be available and willing to work such weekends and holidays as the employer determines are necessary or desirable to meet its business needs.
- Physical Demands
